Methodology

This six-month program is offered in a blended training format, in which CAF provides asynchronous virtual lessons and keynote lectures with international experts, while partner universities offer synchronous virtual and in-person classes. In addition, cross-university virtual classes are delivered among the program's participating universities.

The diploma consists of four phases, some of which run simultaneously:

At the end of the six-month diploma program, up to 20 top projects from the region will advance to **Phase 4**. In this in-person phase, each team will present their project to the other winning groups, international experts, CAF officials, and invited guests. Teams will have the opportunity to refine their projects through feedback and lessons learned. Only one representative per project will attend the bootcamp in person; the rest of the team may participate virtually. The representative will be selected by all team members and must meet certain conditions that will be communicated in due course.

Syllabus

This diploma is divided into three modules, with a total duration of six months. The CAF lessons have a regional and cross-cutting scope, while those delivered by the partner university are more applied and focused on the national context. Of the 20 CAF lessons, 6 are selected by CAF as mandatory, and 6 are chosen by each university as mandatory. In addition, the universities deliver 11 mandatory lessons.

What will you learn?

Design Thinking is a people-centered methodological approach that enables the generation of innovative solutions to public problems. Through its five phases (Empathize, Define, Ideate, Prototype, and Test), it promotes creativity, collective intelligence, and empathy, facilitating the design of sustainable, inclusive, and impact-oriented projects.

You will acquire useful tools to address innovation challenges, which will be presented throughout the program. Some of these tools include:



Additionally, we will work with agile approaches such as Scrum and Kanban, applied to project management in the public sector.

What is sought with the projects?

CAF will present innovation challenges that participants will address from a local perspective. The goal is to create innovative, sustainable, and inclusive projects that involve different sectors. The projects will be developed in teams through four design phases, and the top 20 will be selected to present at an in-person acceleration Bootcamp. Each finalist team will send a representative to the event.

CAF will certify all participants who complete their projects in the use of the methodology, whether or not they are selected as finalists.




